- 1. This petition by way of Second Motion is admitted and fixed for hearing and final disposal on 24.12.2021
- 2. It is submitted that in terms of Order dated 16th August 2021 passed by this Tribunal in Company Application No. CA(CAA)-58(AHM)2021, the meetings of all the Equity Shareholders of Applicant Transferor Company and meetings of Unsecured and Secured creditors of both the Applicant Companies were dispensed with. In respect to the Equity Shareholders of the Transferee Company, directions were issued for the convening of their respective meetings vide the same order.
- 3. Subsequently, in compliance with the order dated 16th August, 2021the aforementioned meetings were duly convened on 7th

October 2021 and the proposed Scheme was unanimously approved by the members present and voting in the respective meetings. The reports of the Chairperson and Scrutinizer have also been placed on record. The reports were filed on 12.10.2021 and the present petition is filed within time.

- 4. It is therefore now directed that the notice of final hearing is fixed for 24.12.2021 and shall be advertised in the daily newspapers namely, the "Free Press" in English and "Lokmitra" in Gujarati having circulation in Surat, not less than 10 days before the aforesaid date fixed for hearing.
- 5. In addition to the above public notice, the petitioner companies shall individually serve the notice of the Petition on the following Authorities namely, (a) to the Central Government through Regional Director (Northern -Western Region) at Ahmedabad, (b)to the Registrar of Companies, at Ahmedabad, Gujarat (c) to the concerned Income Tax Department within whose jurisdiction the Petitioner Companies' assessment is made (d) to the Official Liquidator attached to High Court of Gujarat, (e) to the Securities and Exchange Board Of India (f) BSE Limited at least 30 days before the date fixed for hearing of the above Petition.
