Ambedkar slogan in Class 5 textbook to be corrected

GANDHINAGAR, AUGUST 6

THE GUJARAT government has decided to correct a mistake in a famous slogan by Dr BR Ambedkar in one of the Class 5 textbooks of Gujarat State Board of School Textbooks (GSBST). A decision was taken by the authorities after a meeting with Education Minister Bhupendrasinh Chudasama on Monday.

Last week, The Indian Express reported that a group of Ambedkarites from Gujarat had submitted a protest letter to the Chief Minister's Office against "tweaking" of the historic slogan given by Dr Ambedkar in the Class 5 textbook. The same letter was also given to Deputy CM Nitin Patel, Chudasama and Social Justice & Empowerment Minister Ishvar Parmar. Following this, Chudasama called a special meeting of the officials of the Education department and GSBST Monday where it was decided to correct the slogan.

Speaking with The Indian Express, P Bharathi, Director of GSBST, said, "It was decided (in the meeting with the Education

an inquiry is also on to fix responsibility of how this tweaking of slogan happened and got printed in the textbook.

Speaking with The Indian Express, Chudasama said, "We have given instructions to make a correction in that chapter of the textbook. However, to ensure that those who have complained feel that they have been heard, a meeting will be called tomorrow (Tuesday) by Bharathi madam."

The slogan by Ambedkar in the context - Educate, Agitate, Organise - has become synonymous with the Dalit movement in Gujarat. In Gujarati, it is popular as, "Shikshit Bano, Sangathhit Bano Ane Sangharsh Karo,'

However, a part in the chapter titled 'Bharat Rama - Dr Ambedkar', written by Hasyada Pandya, reads (in Gujarati), "Babasaheb nu ek sutra ganthhe bandhva jevu chhe: Shikshit bano, Sangathhit Bano, Swavlamban j Sachi Sahay Chhe. (One slogan of Babasaheb is worth remembering: Educate, organise and self-reliance is the true assistance.)"
